



Waiver of Liability

I, the undersigned, understand that taking care of _____, my dog, is an inherently difficult activity. I hereby waive, release and forever discharge Shoshanna's Dog Care (the "Company") including its agents, employees, successors and assigns, and their respective heirs, personal representatives, affiliates, successors and assigns, and any and all persons, firms or corporations liable or who might be claimed to be liable, whether or not herein named, none of whom admit any liability to the undersigned, but all expressly denying liability, from any and all claims, demands, damages, actions, causes of action or suits of any kind or nature whatsoever, which I now have or may hereafter have, arising out of or in any way relating to any and all injuries and damages of any and every kind, to my dog, any other dog, any person and/or any property, and also any and all injuries and damages that may develop in the future, as a result of, or in any way relating to, the Company's watching and/or possession of my dog.

Although all dogs being watched by the Company are required to be vaccinated, it is still possible for a dog to become ill with a contagious condition. I understand and acknowledge this risk and agree that the Company is not liable for any expense related to illness suffered by my dog during or after its stay, including, but not limited to Tracheobronchitis (Kennel Cough), Feline Upper Respiratory Infections, Parvo, Distemper, Leptospirosis, Giardia, or Canine Influenza.

I represent that I am the owner of my dog or that I am authorized by the owner of my dog and that I am fully authorized to enter into this Waiver. All of the information about me and my dog contained in this Waiver is true, accurate and complete. I agree to indemnify and hold the Company harmless, from and against all loss, damage or expense, including attorneys' fees, resulting from misrepresentations by me or my representatives or resulting from my dog's stay including, without limitation, any person claiming to be the owner of my dog and any person claiming damage or injury by my dog.

I ACKNOWLEDGE AND AGREE THAT IN THE UNLIKELY EVENT THAT MY DOG IS INJURED OR HARMED IN ANY CAPACITY, I RELEASE AND DISCHARGE THE COMPANY AND ITS AGENTS FROM ANY LIABILITY FOR SUCH INJURY OR HARM.

If my dog injures another dog or any person, I will be solely responsible for any injury to the other dog or such person, as well as any injury to my dog. In the event that my dog is involved in an incident (e.g., biting a person or another dog) ("Incident"), I acknowledge and agree, that the Company may, at its sole and absolute discretion, and hereby authorize the Company to release my name and contact information to any party involved in the Incident and/or the appropriate governmental authority and I RELEASE AND DISCHARGE THE COMPANY AND ITS AGENTS FROM ANY LIABILITY FOR SUCH INCIDENT.

It is understood and agreed that this Waiver is made and received in full and complete settlement and satisfaction of the causes of action, claims, and demands mentioned herein.

This Waiver contains the entire agreement between the parties. The terms of this Waiver are contractual and not merely a recital. Furthermore, this Waiver shall be binding upon the

undersigned, and their respective heirs, executors, administrators, personal representatives, successors, and assigns.

This Waiver shall be subject to and governed by the laws of the State of New York.

This Waiver has been read and fully understood by the undersigned.
